Your image will be processed for archival and promotional purposes on the basis of your consent, i.e. pursuant to Article 6, section 1 of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (Acts. Office. OJ EU L No. 119, p.1).
- 4. Your image can be shared with the following entities: the media cooperating with the University and entities printing informational materials.
- 5. Your image will be stored until the withdrawal of your consent.
- 6. The consent given by you is voluntary. If you do not consent to the photographing and recording of your image you are requested to leave the area of the University and notify the photographer that you do not consent to the use of your image.
- 7. We do not transfer your data outside the EU.
- 8. Please be informed that the Administrator does not process your personal data in a manner based on automated processing, including profiling.
- 9. You have the right to access the content of your personal data, receive a copy thereof and, subject to the provisions of the law, you are also entitled to:
 - a) withdraw the consent given, with the proviso that the withdrawal of consent will not affect the lawfulness of the processing performed on the basis of your consent prior to its withdrawal,
 - b) have the data erased,
 - c) restrict the processing of personal data;
 - d) lodge an objection,

- 10. You are entitled to bring a complaint to the President of the Office for Personal Data Protection in the case of finding that the processing of the image as personal data violates the generally applicable regulations in this regard.
